## PROGRAM DESCRIPTION

This short 2 hour course is a practical, hands-on presentation to develop the attendee's knowledge of and responsibilities toward silica exposure. The course develops the competent person's ability to assess their workplace for silica hazards. Using the OSHA Small Entity Compliance Guide, attendees will create a basic exposure control plan including requirements for employee training, and medical surveillance. The course overviews how and when attendees can and should reach out to get more advanced help.
